### ***The Hotel and its Management are committed to:***

- Comply with any legislative or other requirement to which its activities fall and are related to the management of waste in general and food in particular
- Identify and evaluate food waste flows in the context of its activities with the aim of reducing or even eliminating it
- To ensure food donated or redistributed is free from risks, protecting the health of their final consumers
- Seek through the establishment of objectives, the continuous improvement of food waste resulting from its activities as well as the reduction of the Hotel's food waste

### ***Based on these commitments the Hotel aims to:***

- Design menus and production processes that minimize food waste
- Design a methodology for presenting and serving meals that minimize food waste
- Promote the donation of food that is safe for consumption to socially sensitive groups in collaboration with social partners
- Investigate the possibilities of diverting food waste to other processing units besides landfills
- Apply appropriate circular economy practices in the above actions
- Inform all the bodies with which it cooperates and/or associates about the actions carried out by the company with the aim of raising their awareness and participation
- Train and raise awareness of its staff in order to actively participate in the food waste reduction system
- Inform customers about actions aimed at encouraging their active participation

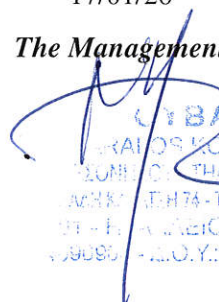
